Red Bluff Joint Union High School District is self-insured; so please help us keep premiums and deductibles low by taking very good care of the Chromebook. The provisions in this policy restrict coverage. The Chromebooks are RBJUHSD property and any damage is the responsibility of the parent/guardian.

Please read this policy to understand your family's rights and responsibilities and what is covered.

A. Costs

1. Yearly premium of **\$30 or \$100** for all four (4) years of high school.
2. If there is a claim for **repairable** damage, there is a **\$10 Deductible** for the first claim.
3. Students, who have insurance claims on their Chromebook more than two times during a school year, for their regular, or replacement Chromebook, will face higher per-breakage deductibles. **The deductible for the second insurance claim, and any claims thereafter, will be \$25 per claim.**
4. If a Chromebook is lost, stolen, or damaged beyond repair, a yearly premium of \$75 will be charged for the replacement Chromebook. If the same situation arises again, it will be determined by the administration if the student will receive another Chromebook.

B. Covered Equipment

1. The insurance provided applies to any Chromebook issued to your child by the Red Bluff Joint Union High School District, whether it is the originally issued Chromebook, or a replacement.
2. Chargers are **NOT** covered under this insurance policy.

C. Exclusions

RBJUHSD will **NOT** pay for loss or damage caused by or resulting from the following:

1. Not informing the district immediately of damage to the Chromebook may void the insurance coverage for that incident. Examples being: damage from a liquid spill, dropping of the Chromebook that may expose internal parts.
2. Loss caused by inappropriate electrical use by using an inappropriate charger.
3. Dishonest, fraudulent, or criminal acts.
4. Theft not accompanied by a police report.
5. Chargers are **NOT** covered under the insurance policy.

D. Claim Procedures

1. Go directly to the IT department to initiate a claim.
